AMENDMENT IN THE NATURE OF A SUBSTITUTE TO H.R. 3400

OFFERED BY MR. GOOD OF VIRGINIA

Strike all after the enacting clause and insert the following:

1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Small Businesses be-
3	fore Bureaucrats Act''.
4	SEC. 2. INCREASE OF DOLLAR THRESHOLD FOR NATIONAL
5	LABOR RELATIONS BOARD JURISDICTION
6	OVER CERTAIN LABOR DISPUTES.
7	(a) In General.—Section 14(c) of the National
8	Labor Relations Act (29 U.S.C. 164(c)) is amended—
9	(1) by redesignating paragraph (2) as para-
10	graph (3); and
11	(2) by inserting after paragraph (1) the fol-
12	lowing:
13	"(2) In establishing by rule any dollar threshold with
14	respect to a class or category of employers for the pur-
15	poses of declining to assert jurisdiction over certain labor
16	disputes involving such class or category of employers, the
17	Board shall establish such dollar threshold at an
18	amount—

1	"(A) for calendar year 2024, equal to the prod-
2	uct of—
3	"(i) the dollar threshold applicable to such
4	class or category as of the day prior to the date
5	of enactment of this paragraph, multiplied by
6	"(ii) ten; and
7	"(B) for any calendar year after 2024, equal to
8	the product of—
9	"(i) the dollar threshold applicable to such
10	class or category for calendar year 2024 (after
11	the date of enactment of this paragraph), multi-
12	plied by
13	"(ii) the quotient obtained by dividing—
14	"(I) the Personal Consumption Ex-
15	penditure Per Capita Index (as published
16	by the Bureau of Economic Analysis) for
17	such calendar year after 2024; by
18	"(II) the Personal Consumption Ex-
19	penditure Per Capita Index for calendar
20	year 2024.''.
21	(b) Personal Consumption Expenditure Per
22	Capita Index.—The Bureau of Economic Analysis of the
23	Department of Commerce shall prepare and publish an
24	index reflecting expenditures for personal consumption by
25	Americans on a per capita basis for each year, beginning

- 1 calendar year 2025, and such index shall be known as the
- 2 "Personal Consumption Expenditure Per Capita Index".
- 3 (c) Effective Date.—The amendments made by
- 4 this section shall apply to any decision of the National
- 5 Labor Relations Board relating to the assertion of its ju-
- 6 risdiction over a labor dispute made after the date of en-
- 7 actment of this section.
